The following is the local educational agency's (LEA's) plan for providing supplemental instruction and support to students, including those identified as needing academic, social-emotional, and other supports, including the provision of meals and snacks. The plan will explain how the LEA will use the funds it receives through the Expanded Learning Opportunities (ELO) Grant to implement a learning recovery program for at least the students included in one or more of the following groups: low-income students, English learners, foster youth, homeless students, students with disabilities, students at risk of abuse, neglect, or exploitation, disengaged students, and students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

### Plan Descriptions

A description of how parents, teachers, and school staff were involved in the development of the plan.

The district engaged stakeholders through the 2020-21 school year to discuss providing instructional supports and interventions. Surveys related to distance learning, technology, and in person instruction were given to parents. The LCAP survey included questions about extended learning opportunities.

Teachers and the district's learning director were consulted on ideas for extended instructional learning, closing learning gaps, school meal program, mental health, and professional development in the areas of trauma-informed education and social-emotional learning.

A description of how students will be identified and the needs of students will be assessed.

Using demographic data, enrollment and school records, and staff or family recommendations, the district will identify which of its students meet one or more of the following criteria:

Low-income student

English learner

Foster youth

Homeless student

Students with disabilities

Students at risk for abuse, neglect, or exploitation

Disengaged students

Students below grade level

These identified students will be assigned priority to receive expanded learning during the regular school day and for the opportunity to participate in the district's expanded learning programs.

Students' academic needs will be assessed using the iReady assessment and/or the California State Standards Assessment (SBAC). Teachers, the site principal, the learning director, and response to intervention (RTI) teachers will use this data to create small RTI groups. Students will be given pre and post assessments at the beginning and end of each RTI session to track progress.

A description of how parents and guardians of students will be informed of the opportunities for supplemental instruction and support.

The student groups as described above and other students identified by certificated staff were identified and prioritized to participate in the district's expanded learning programs.

In the described process of examining data and considering staff and parent recommendations, the students among the groups listed above will be identified as needing services. Also, those submitted by teachers to the principal. Families will be contacted using phone calls, emails, and letters mailed to their homes to be made aware of their student's opportunity to participate in the district's expanded learning programs.

Parents of students who qualify will be notified through phone calls, emails, blackboard connect ed communication, and mailed notices.

At the beginning of the 2021-22 school year, parents will again be notified of the opportunities to receive expanded learning program services.

The plan will be discussed and approved in a public-school board meeting. The principal will also send out a newsletter at the beginning of the school year explaining these supports and articulating that the programs were developed from the results of the LCAP parent and community survey and the LCAP student survey (6th-8th grades).

A description of the LEA's plan to provide supplemental instruction and support.

The district will hire an additional Response to Intervention (RTI) teacher to assist with learning loss in grades TK-8. The district will mandate thirty to forty-five minutes of response to intervention time that will be blocked out each day in every classroom. Students will be placed into small groups based on their most significant learning gaps. During this focused RTI time block, students will be placed into groups for focused instruction. The following certificated employees will work with a group (classroom teacher, two response to intervention teachers, resource teacher, and learning director)

The district placed paraprofessional teacher's aides in each classroom when we returned to in-person learning in March of 2021. Teacher's aides provide support to the teachers and the students in the areas of health and safety protocols and academic instruction.

A description of how ELO Grant funds are being coordinated with other federal Elementary and Secondary School Emergency Relief Funds received by the LEA.

The Elementary and Secondary School Emergency Relief Funds (ESSER) are federal categorical funds that will be used to supplement the activities being funded by the ELO Grant. These uses may be for activities not covered by the ELO Plan or to provide additional services not included, but complementary to the Plan, such as additional supports and interventions, contracted services to support students' social-emotional needs, professional development, or other activities. The determination of specific ESSER-funded actions may be based on needs that have been identified after the District has begun implementation of its expanded learning program activities and has monitored and evaluated those activities using students' progress data.



# Expanded Learning Opportunities Grant Plan Instructions: Introduction

The Expanded Learning Opportunities Grant Plan must be completed by school districts, county offices of education, or charter schools, collectively referred to as Local Educational Agencies (LEAs), that receive Expanded Learning Opportunities (ELO) Grant funds under California *Education Code (EC)* Section 43521(b). The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before June 1, 2021, and must be submitted to the county office of education, the California Department of Education, or the chartering authority within five days of adoption, as applicable. The plan must be updated to include the actual expenditures by December 1, 2022.

## Instructions: Plan Requirements

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- “Supplemental instruction” means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- “Support” means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students’ needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.

- “Students at risk of abuse, neglect, or exploitation” means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

*EC* Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
  - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
  - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
  - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students’ college eligibility.
6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students’ social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

### **Fiscal Requirements**

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.
- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
