## 2017-20 Plan Summary

## The Story

Describe the students and community and how the LEA serves them.

Raymond Knowles Union Elementary School District (RKUESD) is a single-school district located in the town of Raymond, an unincorporated community of less than 1,000 residents situated in the foothills of Eastern Madera County.

The district encompasses 196.7 square miles of sparsely populated foothills. Currently, the district serves a diverse population of 82 students enrolled in grades K-8, 10% of whom are American Indian, 6% two or more races, 22% Hispanic, 58% White, and 5% other. 61.48% of our students meet the state's definition of "unduplicated pupils."

The mission of the Raymond-Knowles Union Elementary School District is to educate all students in a challenging, disciplined, safe, and supportive environment, so they can reach their full potential of becoming productive citizens of high moral character, making life-long contributions to society.

Students are taught by four teachers assigned to multi-grade classrooms; one Learning Director; and one Resource Teacher. One school and district secretary, one site administrator (superintendent/principal), and two maintenance workers/bus drivers provide support to the educational program.

Students at RKUESD are instructed in 21st century skills that include the learning areas of core academic subjects using 21st century themes of life and career skills, critical thinking, communication, collaboration, creativity, technology, and information/media literacy.

We are a 1:1, student to device school. Every student in grades Kindergarten through eighth grades has a computer or technology device assigned to them. Kindergarten through first grades use iPad minis. Second through eighth grades uses Chromebooks. We are also a Google Apps For Education (GAFE) school. All of our teachers are in the process of becoming Google Certified Teachers.

We take pride in our students work and accomplishments. We host a student showcase event once a month where we invite the community to the school to see students work on display. Students share with their families and the community what they have learned and created in school. These events have fostered a positive relationship between the school and community.

The Governing Board is a group of publicly-elected volunteers who are stakeholders in the community and are active in the school program.

## **LCAP Highlights**

Raymond Knowles UESD is committed to educating the whole child in a supportive environment. To that end, the LCAP highlights the following:

To support teachers in improving their craft, and in providing best first instruction, the Learning Director facilitates meetings to discuss instructional practices, student data analysis, and positive classroom culture and environment. Teachers are being trained to implement Project Based Learning into lessons and units of study.

To ensure technology most effectively supports instruction, teachers attend Google Certification Boot Camps and other GAFE workshops/conferences to learn GAFE tools.

To support at-risk students, counseling services are provided, along with in-class and out of class academic interventions for students.

Our Student Showcase events engage students, parents, and the community-at-large in a positive demonstration of students' learning.

## **Review of Performance**

## **Greatest Progress**

English Language Arts – After a remarkable increase of 45.8 points the preceding year, the Fall, 2017, mean students' score school-wide on the California School Dashboard was at 8.2 points below Level 3 (Standard Met), a slight drop from the prior year. Because of the small numbers of students assessed, results can be very volatile; the district is pleased to have come close to maintaining the growth from the prior year.

Mathematics – The prior year's increase of 35.3 points in math was also remarkable, and growth continued with the Fall, 2017, Dashboard results. They increased by 1.5 points to 31.1 points below Level 3 (Standard Met). Students who were in the Socioeconomically Disadvantaged group increased by 7.3 points, and Hispanic students increased by 7.2 points. Achievement gaps between student groups in math continue to narrow.

On the LCAP survey for the statement, "The school focuses on creating excitement and engagement for all students and families." The school received a 5 (strongly agree) for 87% -- and increase of 18% -- of the responses and a 4 (agree) for 8.7% of the responses.

Fifty percent of RKUESD teachers have achieved Google Certified Educator status.

The District will continue to improve first teaching, provide interventions, and add a part-time Response to Intervention teacher to build on and improve the academic assessment results and other indicators on the California School Dashboard.

#### **Greatest Needs**

On the state's Fall, 2017, Dashboard, the Suspension Rate Indicator for All Students was in the "High" (5.2%) and "Increased" (+3%) ranges, resulting in placement in the Orange Category. This is due, in large part, to having a small population in which a few students can cause wide swings in results. For example, the Dashboard results don't show that, between the two reporting periods, the district's suspension rate fell to 2.2%, or that the state's DataQuest website shows that each student suspended raises the rate by a full percentage point.

To lower the suspension rate, the district will continue to implement positive behavior interventions. Raymond-Knowles Elementary will also continue to provide counseling services to high-risk students and families.

The District was also in the Orange Category ("Low", "Maintained") for both English Language Arts and mathematics.

The district will continue to offer the best possible services to our students, and continue the LCAP improvement actions and services. (See the "Increased or Improved Services" section below.) Students' growth in academics and the closing of achievement gaps over the past few years indicates our efforts have been effective.

#### **Performance Gaps**

The district has no performance gaps, based on the definition above.

## **Increased or Improved services**

The Learner Director will spend 50% of the work day providing academic support to students and teachers of students who are not meeting academic standards, principally directed to those who are socioeconomically disadvantaged, English learners, or foster youth.

Teachers will be provided coaching and support for improving instruction and providing in-class remediation.

Teachers will be given time to prepare resources for families on how they can help their student(s) at home to assist them in mastering content and academic standards, and support their children's learning needs.

An additional part time certificate employee will be hired to provide Response To Intervention (RTI) to students who fall one or more grade levels below standard in Language Arts and/or Mathematics. (This position will be funded with S&C monies)

Describe the overall implementation of the actions/services to achieve the articulated goal.

As noted in the "Actual Actions," the Learning Director consistently held bi-weekly meetings with teachers to discuss best teaching strategies, implementation of CCSS, and to review student data. The Learning Director also helped teachers with implementing technology into their instruction. Teachers took advantage of several professional development opportunities. Implementation was lagging in teachers presenting outside the District. Roving subs were not hired because our Learning Director's day was filled with intervention classes, teaching eighth grade math, and management tasks.

Describe the overall effectiveness of the actions/services to achieve the articulated goal as measured by the LEA.

It appears that our actions and services for goal one were effective. Teachers are continuing to work towards level one and two Google Certification. Teachers and students were successful in creating digital portfolios for all students K-8 in their Google Dive or in a program called SeeSaw. The Learning Director was effective and consistent with teacher meetings. Teachers became much more effective in areas of their instruction that were weak as well as becoming more efficient with understanding data and using it to drive their instruction.

There were no material differences in budgeted and actual expenditures.

The district was able to minimally implement Action 4, but was not able to implement action 5. Stakeholders agreed that having an action encouraging teachers to present is a good idea, so it will be continued. Also, the district found that it was able to meet its needs for teachers to observe others by meeting with the Learning Director Biweekly to discuss teaching practices that need improving. Stakeholders agreed that it would better serve our Unduplicated Pupils to discontinue Goal 1, Action 5, from a roving sub for teachers' release time, and **add Goal 1, Action 6**, a part-time Response to Intervention teacher to support students.

These actions and services were implemented to achieve the articulated goal. Our part-time custodian was moved to full-time as food services director and maintenance to help maintain the interior and exterior of the facilities and grounds. Counseling services were on campus once a week to serve at-risk students. Our Learning Director met with teachers bi-weekly to discuss best practices for both classroom instruction and classroom management. The school safety plan and the discipline policy were to be reviewed and updated if needed by staff, SSC, and the RKUESD School Board, so they were regularly discussed.

The overall effectiveness of these actions and services was satisfactory. To lower the suspension rate, the district will continue to implement positive behavior interventions. Raymond-Knowles Elementary will also continue to provide counseling services to high-risk students and families.

It appears the effectiveness of our actions and services for Goal 3 were effective. Our students' SBAC results are coming in and the data are being looked at by our Learning Director and the principal.

The significant difference in budgeted and estimated expenditures was due to revising our technology plan in an effort to phase out our old technology and have a plan in place that allows the district to replenish old devices every five years.

Since the student population is 61.48% unduplicated pupils, this allocation of resources is believed to be the best way of improving learning for all students. Academic assessment results from the California State Dashboard seem to bear this out, as all student groups have maintained significant increases in academic performance.

The Learning Director position plays a critical role in meeting all five of goals in this plan.

For the 2018-2019 school year, the Learning Director's services will benefit unduplicated pupils by helping teachers improve their teaching craft. Common Core units and lessons will continue to be developed, reviewed, and improved upon with the coaching and support of the Learning Director. The additional time to prepare for parent teacher conferences will allow teachers to gather student work samples to share with parents about their students' progress towards mastery of CCSS. This time will also allow for teachers to prepare resources to families on how they can help their student(s) at home to assist them in mastering CCSS.

For charter schools and single-school school districts, "LEA-wide" and "Schoolwide" may be synonymous and, therefore, either would be appropriate. - B. How the school district will promote parental participation in programs for unduplicated pupils; and
- C. How the school district will promote parental participation in programs for individuals with exceptional needs.

## Priority 4: Pupil Achievement as measured by all of the following, as applicable:

- A. Statewide assessments;
- B. The Academic Performance Index:
- C. The percentage of pupils who have successfully completed courses that satisfy University of California (UC) or California State University (CSU) entrance requirements, or programs of study that align with state board approved career technical educational standards and framework;
- D. The percentage of English learner pupils who make progress toward English proficiency as measured by the California English Language Development Test (CELDT);
- E. The English learner reclassification rate:
- F. The percentage of pupils who have passed an advanced placement examination with a score of 3 or higher; and
- G. The percentage of pupils who participate in, and demonstrate college preparedness pursuant to, the Early Assessment Program, or any subsequent assessment of college preparedness.

#### **Priority 5: Pupil Engagement** as measured by all of the following, as applicable:

- A. School attendance rates;
- B. Chronic absenteeism rates:
- C. Middle school dropout rates:
- D. High school dropout rates; and

E. High school graduation rates;

**Priority 6: School Climate** as measured by all of the following, as applicable:

- A. Pupil suspension rates;
- B. Pupil expulsion rates; and
- C. Other local measures, including surveys of pupils, parents, and teachers on the sense of safety and school connectedness.

**Priority 7: Course Access** addresses the extent to which pupils have access to and are enrolled in:

- A. S broad course of study including courses described under *EC* sections 51210 and 51220(a)-(i), as applicable;
- B. Programs and services developed and provided to unduplicated pupils; and
- C. Programs and services developed and provided to individuals with exceptional needs.

**Priority 8: Pupil Outcomes** addresses pupil outcomes, if available, for courses described under *EC* sections 51210 and 51220(a)-(i), as applicable.

**Priority 9: Coordination of Instruction of Expelled Pupils (COE Only)** addresses how the county superintendent of schools will coordinate instruction of expelled pupils.

**Priority 10. Coordination of Services for Foster Youth (COE Only)** addresses how the county superintendent of schools will coordinate services for foster children, including:

- A. Working with the county child welfare agency to minimize changes in school placement
- B. Providing education-related information to the county child welfare agency to assist in the delivery of services to foster children, including educational status and progress information that is required to be included in court reports;
- C. Responding to requests from the juvenile court for information and working with the juvenile court to ensure the delivery and coordination of necessary educational services; and
- D. Establishing a mechanism for the efficient expeditious transfer of health and education records and the health and education passport.

#### Local Priorities address:

- A. Local priority goals; and
- B. Methods for measuring progress toward local goals.

# APPENDIX A: PRIORITIES 5 AND 6 RATE CALCULATION INSTRUCTIONS

For the purposes of completing the LCAP in reference to the state priorities under *EC* sections 52060 and 52066, as applicable to type of LEA, the following shall apply:

  - (2) The unduplicated count of pupils with a primary, secondary, or short-term enrollment during the academic year (July 1 June 30).

- (b) "Middle School dropout rate" shall be calculated as set forth in 5 CCR Section 1039.1.
- (c) "High school dropout rate" shall be calculated as follows:
  - (1) The number of cohort members who dropout by the end of year 4 in the cohort where "cohort" is defined as the number of first-time grade 9 pupils in year 1 (starting cohort) plus pupils who transfer in, minus pupils who transfer out, emigrate, or die during school years 1, 2, 3, and 4.
  - (2) The total number of cohort members.
  - (3) Divide (1) by (2).
- (d) "High school graduation rate" shall be calculated as follows:
  - (1) The number of cohort members who earned a regular high school diploma [or earned an adult education high school diploma or passed the California High School Proficiency Exam] by the end of year 4 in the cohort where "cohort" is defined as the number of first-time grade 9 pupils in year 1 (starting cohort) plus pupils who transfer in, minus pupils who transfer out, emigrate, or die during school years 1, 2, 3, and 4.
  - (2) The total number of cohort members.
  - (3) Divide (1) by (2).
- (e) "Suspension rate" shall be calculated as follows:
  - (1) The unduplicated count of pupils involved in one or more incidents for which the pupil was suspended during the academic year (July 1 June 30).
  - (2) The unduplicated count of pupils with a primary, secondary, or short-term enrollment during the academic year (July 1 June 30).
  - (3) Divide (1) by (2).
- (f) "Expulsion rate" shall be calculated as follows:

- (1) The unduplicated count of pupils involved in one or more incidents for which the pupil was expelled during the academic year (July 1 June 30).
- (2) The unduplicated count of pupils with a primary, secondary, or short-term enrollment during the academic year (July 1 June 30).
- (3) Divide (1) by (2).
